



PUBLIC NOTICE No.16/2026

In pursuance of Notification No. 12/97-Customs (N.T.) dated 02.04.1997, as amended, issued under Section 7 of the Customs Act, 1962, whereby Jodhpur in the State of Rajasthan has been notified as an Inland Container Depot for unloading of imported goods and loading of export goods, I, R.K. Chandan, Commissioner of Customs, Jaipur, in exercise of the powers conferred under Section 8 of the Customs Act, 1962, hereby amend Public Notice No. 17/2001 dated 25.06.2001 by revising the limits of the Customs Area of the Inland Container Depot (ICD) located at Railway Goods Shed, New Power House Road, Bhagat Ki Kothi, Jodhpur, District Jodhpur, as under:-

North: Coordinates from Point C (N26.259649, E73.012245) to D (N 26.259295, E-73.013626) boundary wall of length **167.63 metres** from north-west side, adjacent to the private residential area.

East : Coordinates from A (N26.259312, E73.013626) to D (N26.259295, E-73.013626), **24.01 metres** long boundary wall including entry and exit gate to existing ICD BGKT.

South: Coordinates from A (N26.259312, E73.013626) to B (N26.259207, E73.013123), **175.43 metres** long boundary wall from south to east. Adjacent to approach road to ICD and Rail Yard and rail sports stadium.

West: Coordinates from B(N.26.259207, E73.013123) to C (N26.259649, E73.012245), **50 metres** long boundary wall from north to west adjacent to proposed railway Electric substation.
