MINUTES OF MEETING OF CUSTOMS CLEARANCE FACILITATION COMMITTEE (CCFC) AND THE PERMANENT TRADE FACILITATION COMMITTEE (PTFC)

MEETING HELD ON 09.12.2021

The meeting of the Permanent Trade Facilitation Committee (PTFC) for Customs Commissionerate (Preventive) Jodhpur, was held on 09.12.2021 at 11:00 A.M. which was chaired by Shri Rahul Nangare, Commissioner of Customs Commissionerate (Preventive) Jodhpur. - 2. The Chairman started the meeting with welcome address to all the Members.
- The following issues were raised by GJEPC, Jaipur-
- i. Shri Punit Kumar Saini/ Nitin Khandelwal apprised the Chairman that nominated agencies were supplying duty free precious metals from their DTA warehouses to a SEZ unit in pre-GST era which was discontinued in GST regime due to lack of clarity in the process of bond discharge by Customs in such supplies. He further requested for issuance of public notice for the same to enable nominated agencies start such supplies to SEZ units.

Reply given by the Department: The Chair assured to examine the issue in due course and

informed that as no such public notice has been issued from any Commissionerate. Therefore worthy commissioner formed the a committee headed by ADC on this issue to have meeting with the trade and to prepare draft SOP with the help of trade itself for Public notice, further submission and approval of CBIC, New Delhi.

ii Shri Akash Alha, Chief Accounts Officer Rajsico Jaipur requested in r/o ACC Jaipur, that no airline is accepting cargo due to BCAS restriction on RAJSICO. As a result, since January 21, they are not able to book /clear any General Cargo from this port for export. The trade is facing hardship due to this problem and gradually the export of General Cargo is being diverted to other ports.

Reply given by the Department: The Chairman informed that approval of AAICLAS for custodianship is under process. The custodianship of new Air Cargo Complex at International Airport, Jaipur has been granted to AAICLAS by Notification No. 01/2021 dated 10.12.2021 which will sort out this issue.

iii Proforma demanded by Customs officers due to non updation of System :-

During PTFC meeting it was pointed out by trade that some proformas like Appendix III and SDF Declarations are being asked for by the Customs Officers to upload on System as the System is not updated.

During discussion it was suggested by the trade itself that this issue was also raised in earlier PTFC held on 08.03.2019. The Department side is of the opinion that such documents are required to process the documents because if No Proforma is entered in System, the system does not process the document.

Chairman assured that if documents are uploaded through e-Sanchit then such documents won't be asked for. If System related improvements are required then the issue will be raised before DG Systems after ascertaining the factual position.

iv. Issue of non-connectivity of Express Cargo Clearance System (ECCS) at Jaipur Gems Stone Exchange(JGSE):-

Jaipur Gems Stone Exchange (JGSE) submitted that they were facing issue of non connectivity of their Express Cargo Clearance System (ECCS), though they were requesting LAN WAN team(DOT).

It was suggested by the Department side that they may take up the issue through email with details of efforts made by them as well as with readiness status of the router and switches due to which connectivity issue persisted so long.

v. Problems being faced by Gems & Jewellery exporters due to delay in Faceless Assessment :

Gem & Jewellery Export Promotion Council (GJEPC) raised the issue of delay in Faceless Assessment by Faceless Assessment Groups (FAGs) situated outside the jurisdiction of Customs Preventive Commissionerate, Jodhpur.

It was assured by the department that regular monitoring is being done and cases in which delay comes to notice are regularly being taken up with the respective FAGs. The Chairman directed the Port officers to take up all the Bills of Entry pending for more than 2 days with respective FAGs and if it doesn't get resolved at their level then such cases can be escalated to Additional Commissioner.

It was further assured that various measures are being undertaken by the CBIC for expediting Customs clearances under FAGs referring to CBIC Circular No. 14/2021-Customs dated 07.07.2021. as per Circular, the RMS facilitation has already been raised to 90% of total Bills of Entry resulting in lesser Bills of Entry to be assessed at FAGs. Another feature of the said CBIC Circular is referred to at Para 3.7, wherein Anonymized Escalation Mechanism (AEM) has been made operational on ICEGATE which would empower importers/Customs Brokers to directly register their requirement of expeditious clearance of a delayed Bill of Entry,

vi. Agenda points raised by Rajasthan Chamber of Commerce and Industry, Jaipur

The representative of Rajasthan Chamber of Commerce and Industry, Jaipur raised the issue in r/o inverted duty structure, detention of vehicle, Input Credit Mismatch in return and all business at all locations should be allowed at single PAN with single registration.

Reply given by the Department: The Chairman acknowledged that all the representations are related to GST Policy/Act related only. Therefore this in not proper platform to handle these issues. The same may be raised at the level of Chief Commissioner/Principal Commissioner, CGST Commissionerate Jaipur.

5. Thereafter, the Chairman thanked all the members for their cooperation. The meeting concluded with a vote of thanks to the Chair. Next date of the CCFC and PTFC meeting would be communicated well in advance.
