

नोट :-

1. The Additional Commissioner, Customs Sub-Commissionerate, Jodhpur will issue further specific transfer /posting/rotation orders in respective formation in respect of officers mentioned at Sl. No. 55 to 74 in consultation with respective jurisdictional DC/AC. While issuing orders for specific charge/postings, the Transfer Policy Guidelines 2018, HOP of officers, CVC's Circular No. 1/2000 dated 10.05.2020 and existing instructions should be kept in mind, so as to ensure proper rotation and sensitive & non-sensitive norms.
2. All jurisdictional AC/DC incharge should ensure that before relieving the officers, they hand over their charge under proper Handling Over/Taking over note. List of all urgent and time bound matters, pertaining to the important and necessary work should be prepared and handed over to the controlling officer and a copy of the same should be handed over to the successor on issue of current importance, urgency of actionable points, critical issues as envisaged in DOPT OM No. 13024/01/2014-(Trg-Ref) dated 26.09.2014.
3. The officers mentioned at Sl. No. 50 shall not be entitled for any TTA of joining as the transfer is done on his own request.
4. All the representations/requests received in the grade of Inspectors- stand disposed off.


