Sub: Amendment in CBLR, 2018 vide Notification No. 62/2021- Customs (N.T.)-reg.

Attention of the Customs Brokers and other members of trade is invited to Board's Notification No. 62/2021-Customs (N.T.) dated 23.07.2021 and Circular No 17/2021-Customs dated 23.07.2021 wherein as per amended Regulation 9 of CBLR 2018, a license granted under Customs House Agents Licensing Regulations, 1984, the Customs House Agents Licensing Regulations, 2004, the Customs Brokers Licensing Regulations, 2013 or the Customs Brokers Licensing Regulations, 2018 shall be valid unless and until revoked in terms or provisions under sub-regulation (2) of Regulation 8A or Regulation 14.

2. All Customs Brokers seeking such "Life time validity" endorsement on their licenses who are issued licence in Jodhpur (Preventive) Customs Commissionerate Hqrs at Jaipur under Regulation 7(2) of CBLR 2018 or corresponding provisions of earlier CBLR, whose license is operational and fulfilling other conditions as laid down in the Notification cited herein, intimation giving "Life time validity" of their licenses will be soon sent to their office addresses available on record and on their email address, which alone will be sufficient to extend their License validity to Life Time Validity. There is no need for Customs Broker to visit physically to get their license endorsed to this effect.
