2. अध्यक्ष महोदय ने सभी सदस्यों का स्वागत करते हुए बैठक का आरम्भ किया ।
3. The following issues were raised and solution made thereof:-

President, Rajasthan Custom House Agents Association, Rajasthan-

A. ICD RAJSICO, JAIPUR -

Lack of Basic Infrastructure facility at ICD RAJSICO, Mansarovar, Jaipur as follows -

- (i) no Service Centre, Printer, proper sitting arrangement and parking space;
- (ii) no Container tracking system for Export/Import containers;
- (iii) no RSIC person is available to hear any grievance or query. Only H&I staff remains in the office;
- (iv) unauthorised persons roam about freely;
- (v) no 24x7 security arrangements are there. Trailers and other vehicles are parked inside bonded area without customs permission.

In this regard, the Chair asked to Shri Punit Kumar Saini, Incharge representative of RAJSICO for redressal of the grievances of the trade representatives Shri Saini stated that Container Tracking System is under trial run mode & facilities are being improved at the port. Further, the Chair asked AC, Incharge of RAJSICO Jaipur to fix a meeting with MD, RAJSICO & visit the ICD alongwith M RAJSICO and submit the report before next PTFC meeting.

Action - AC, ICD RAJSICO & Custodian of ICD RAJSICO

B. AAICLAS

Non-availability of a Plant Protection Officer for the inspection of perishable goods in AAICLAS Terminal.

In this regard, the Chair asked the jurisdictional AC regarding the query, Smt. Anupama Saksena, Assistant Commissioner, In-charge of AAICLAS, Jaipur stat that they have approached with competent authority of AAICLAS authority and they have assured that they would look into the matter. In addition to that, a letter dated 08.09.2022 has already been issued to the Joint Director (Plant Protection), Rajasthan Department of Agriculture, Jaipur for deployment of Plant protection officer at Jaipur Airport considering the request of trade associations to promote the export & trade facilitation. Further, a letter will be issued to the department of Agriculture, Rajasthan with requesting the controlling authority to attend the PTFC/CCF meeting onwards for trade facilitation.

Action: Rajasthan Department of Agriculture, Jaipur.

- C. ACC - Bill of Entries assigned to FAG officers at Kolkata are invariably being assessed by them provisionally irrespective of the fact whether provisional assessment is required or not. This is causing undue complications and delay in the release of import goods.**

In this matter, the Chair asked trade representatives to submit a letter containing specific issues alongwith facts. Thereafter, this office can forward the

grievances of the trade to the appropriate authority with request to redressal of the grievances of the trade at earliest.

Action: Trade representatives.

4. In addition to agenda points, trade/association representatives has requested to conduct PTFC/CCFC meeting bimonthly. Then, the Cha instructed to conduct the PTFC/CCFC meeting bimonthly onward considering the request of the trade/association representatives.

Thereafter, the Chair thanked all the members for their deliberation. The meeting concluded with a vote of thanks to the Chair. Next date of the CCFC and PTFC meeting would be communicated well in advance.
