अध्यक्ष महोदय ने सभी सदस्यों का स्वागत करते हुए बैठक का आरम्भ किया।

- 3. The following agenda points have been sponsored by RAJSICO, Jaipur-
 - (i) As discussed in last meeting EDI printer is still not working at ICD Jaipur.

As directed by the Chairman in last PTFC/CCFC meeting held on 13.01.2020, a letter was sent to Joint Commissioner, DG Systems, New Delhi to make arrangement for functioning of EDI printer at ICD-RAJSICO, Jaipur.

Vide mail dated 31.01.2020, DG Systems informed that informed that ICD – RAJSICO, Jaipur is a Custodian site, the Custodian can be asked to procure the printer as per HCCAR, 2009 guideline.

In this regard, Regulation 5(k) of HCCAR, 2009 states that adequate air conditioned space and power back up, hardware, networking and other equipment for secure connectively with the Customs Automate System; and for exchange of information between Customs Community partners has to be provided by Custodian.

The Chairman suggested to the Custodian i.e. RAJSICO – Jaipur that they should make arrangements for printer at ICD-RAJSICO at their own cost as per norms laid under Regulation 5(k) of HCCAR, 2009.

- 4. Some of the representative of trade associations requested the Chairman to discuss some points. The Chairman affirmed the request of representative of Trade/CHA Association/ Organization. With the permission of the Chairman following points were also discussed in the meeting:-
 - (i) The Jaipur Gemstone Exchange raised the issue that huge amount of IGST refund is pending due to SB006 Error i.e. filing of TP or EGM at Gateway port.

In this regard, the Chairman directed the Port Incharge ACC/JGE to examine whether TP or EGM at Gateway port is to be filed and also directed to resolve the error as per norms and process the IGST refund.

The Chairman directed that all Port In-charge should take up the matter on priority and wherever IGST Refund is pending due to such Errors may be got resolved.

(ii) Some of the representative of trade associations raised there is only one Expert Valuer is providing services at JGE and ACC, both places.

In this regard, the Chairman told that vide Public Notice No.31/2019 dated 17.10.2019, a Panel of Expert Valuers has been drawn whereby total thirteen Valuers have been nominated which should be good enough. In this regard, the Chairman directed to call for a detailed report from ACC/JGE and Assistant Commissioner to ask each and every nominated Valuer as to why they don't come forward to provide expert service. The Assistant Commissioner would identify name of expert Valuer whom services are not satisfactory so that their name may be deleted from Panel.

(iii) The Assistant Commissioner, JGE, Jaipur raised a point that JGE do not fill up IGST amount in Bills of Entry and the same has to be filled by Customs Official which takes a lot of time.

In this regard, the Chairman told that JGE should fill up BEs in complete manner.

(iv) The Assistant Commissioner, JGE, Jaipur also raised a point that Carrotometer is not functioning properly.

In this regard, the Chairman directed to the Joint Commissioner that calibration of Carrotometer be got checked from engineer and be upgraded calibration, if needed.

5. Thereafter, the Chairman thanked all the members for their deliberation. The meeting concluded with a vote of thanks to the Chair. Next date of the CCFC and PTFC meeting would be communicated well in advance.
