विषय: Minutes of the meeting held on 30.06.2017 with CHAs, Trade Associations and its members at NCRB, Statue Circle, Jaipur in respect of smooth functioning of Customs related work i.e. import, export etc. in the light of new GST Regime w.e.f. 01.07.2017.

A. Re-import of goods exported for exhibition/ consignment sale on or before 30.06.2017:-

• The members of CHA Association and trade association raised that the goods exported on or before 30.06.2017 for exhibition / consignment sale under free shipping bills may be allowed duty free at the time of re-import on or after 01-07-2017 (in new GST regime) as per Notification No. 94/96-Cus dated 16.12.1996.

The Commissioner of Customs, Jaipur agreed with the Trade contention that logically re-import of such goods should not attract any duty even in GST regime. However, as per law IGST is applicable as no exemption Notification has been issued. However, as a Trade facilitation measure, in consultation with Trade, he directed to allow such type of re-imports on provisional basis under simple bond without bank guarantee till the issue is clarified at policy level.

(This issue has been clarified now with issuance of exemption Notification No. 46/2017-Cus dated 30.06.2017 exempting such re-imported goods from Customs duties and IGST)

B. Waiver of Penalty in late filing of B.E. due to system error:-

• The members of CHA Association and trade association raised that in new GST regime, there is possibility that due to lack of knowledge and IGST updation in new EDI System, the importer is unable to file bill of entries in time. The system after a day calculate penalty amount suo motto on late filling of Bill of Entry, which causes unnecessary burden on the importers.

The Commissioner of Customs, Jaipur directed that if any delay in filling Bill of Entry is found to be due to system error, the same will be condoned in terms of sub-regulation (2) of 27/2017-Customs (N.T.) New Delhi, the 31st March, 2017 where the proper officer is satisfied with the reasons of delay, he may waive off the charges referred to in the second proviso to sub-section (3) of the section 46 of the Customs Act, 1962 (52 of 1962).

C Late final printing of export paper after LEO at JGE, Jaipur:-

 The members of CHA Association and trade association represented that at JGSE, Jaipur after grant of LEO for export of goods, final printing of papers could not be effected properly. They complained that sometimes printing takes 5-6 hours from LEO delaying export of consignment.

The Commissioner of Customs, Jaipur directed officers to find out the reasons for such type of delay in final printing of export papers at JGSE and to resolve the same expeditiously.

Further, the member of the trade association were requested to provide a list of importer/exporter with their address, IEC No, GSTIN, PAN, Mobile No of the director/partner/proprietor/authorized person in Excel Sheet for creating a database for better Trade Facilitation and information dissemination. They assured that the same will be provided shortly.
